Administration of Behavioral Health Services Will Transition from MHN to Health Net as of 1/1/2024



Effective January 1,2024, Commercial Group, Ambetter Individual and Family Plan/ and Medi-Cal members' Mental Health and Substance Use Disorder benefits will no longer be administered by MHN. These benefits will be arranged by Health Net. This means members will keep the same great benefits but the MHN name as the administrator will be removed, and these benefits will be known simply as Health Net's Behavioral Health Services.

- These changes will be displayed on the new Member ID card. Members should receive their new card before January 1, 2024.
- There will not be any change to the provider network due to this behavioral health administrator change.* And for the first few months of 2024, Commercial and Medi-Cal members will still use the MHN Provider Search on healthnet.com, and Ambetter Individual and Family Plan members will use the MHN Provider Search on myhealthnetca.com.
- There will be a follow up communication to members in the coming months when members will be able to search for behavioral health Providers on healthnet.com and myhealthnetca.com.


