Important Questions	Answers	Why This Matters:
What is the overall deductible?	For <u>preferred providers</u> \$6,300 person / \$12,600 per family. \$12,600 person / \$25,200 per family for <u>out-of-network</u> <u>providers</u> per calendar year.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , laboratory tests, <u>rehabilitation</u> and <u>habilitation</u> services, <u>hospice</u> ; first 3 non-preventive visits per year combined (including non-preventive primary care, <u>specialist</u> , other practitioner office visits, acupuncture services & medical <u>urgent care</u> visits); mental health, behavioral health or substance abuse <u>urgent care</u> & office visits; pediatric vision and pediatric dental care are covered before you meet your <u>deductible</u> . What is the <u>out-of-</u> <u>pocket limit</u> for this <u>plan</u> ?	For <u>preferred providers</u> \$8,200 per person / \$16,400 per family; for <u>out-of-network providers</u> \$16,400 per person / \$32,800 per family per calendar year.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. What is not included in the <u>out-of-pocket</u> <u>limit</u> ?	Premiums, balance billing charges, drug discount, coupon or copay cards for prescription drugs, penalties for non-certification and health care this plan doesn't cover. Be aware, your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.
Do you need a <u>referral</u> to see a <u>specialist</u> ?	No.	You can see the <u>specialist</u> you choose without a <u>referral</u> .
