Upcoming Provider Portal Changes Effective January 1, 2024

Prepare for how these changes affect your business interaction with us

Starting January 1, 2024, California Health & Wellness Plan (CHWP) members in Amador, Calaveras, Inyo, Mono, and Tuolumne counties will transition to Health Net Community Solutions, Inc., (Health Net*) while members in Imperial County will transition to Community Health Plan of Imperial Valley (CHPIV). These transitions will result in provider portal changes that will impact your work with Health Net.

To ensure a smooth transition, we have provided a summary of these changes below to help you do business with us as of January 1, 2024.
