WHAT THIS MEANS FOR YOU AND HOW TO LEARN MORE

On January 1, 2023, to create an integrated approach to care coordination and provide extra support and resources to patients, members enrolled in a Cal MediConnect (Medicare-Medicaid Plan) or a dual eligible Special Needs Plan (D-SNP) “look alike” will transition to another plan.
