#### Description

Clindamycin phosphate/benzoyl peroxide (Onexton<sup>®</sup>, Acanya<sup>®</sup>) is a topical combination product of two active ingredients: clindamycin phosphate, a lincosamide antibacterial agent, and benzoyl peroxide, an oxidizing agent with bactericidal and keratolytic effects.

### FDA Approved Indication(s)

Onexton and Acanya are indicated for the topical treatment of acne vulgaris in patients 12 years of age and older.

#### **Policy/Criteria**

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Onexton and Acanya are **medically necessary** when the following criteria are met:

### I. Initial Approval Criteria

- A. Acne Vulgaris (must meet all):
  - 1. Diagnosis of acne vulgaris;
  - 2. Age  $\geq$  12 years;
  - 3. Failure of at least two preferred generic clindamycin phosphate/benzoyl peroxide topical products (*see Appendix B*), unless clinically significant adverse effects are experienced or all are contraindicated;
  - 4. Dose does not exceed 1 pump container per month.

## Approval duration: 12 months or duration of request, whichever is less

#### **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial; or

2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial.

## **II.** Continued Therapy

- A. Acne Vulgaris (must meet all):
  - 1. Member meets one of the following (a or b):
    - a. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
    - b. Member is currently receiving medication and is enrolled in a state and product with continuity of care regulations (*refer to state specific addendums for CC.PHARM.03A and CC.PHARM.03B*);
  - 2. Member is responding positively to therapy;

# 3. If request is for a dose increase, dose does not exceed 1 pump container per month. Approval duration: 12 months or duration of request, whichever is less

- **B.** Other diagnoses/indications (must meet 1 or 2):
  - 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
    - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial; or
    - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial; or
  - 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial.

### III. Diagnoses/Indications for which coverage is NOT authorized:

**A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial or evidence of coverage documents.

- Contraindication(s):
  - Hypersensitivity (e.g., anaphylaxis) to clindamycin, benzoyl peroxide, any components of the formulation, or lincomycin
  - History of regional enteritis, ulcerative colitis, or antibiotic-associated colitis
- Boxed warning(s): none reported
